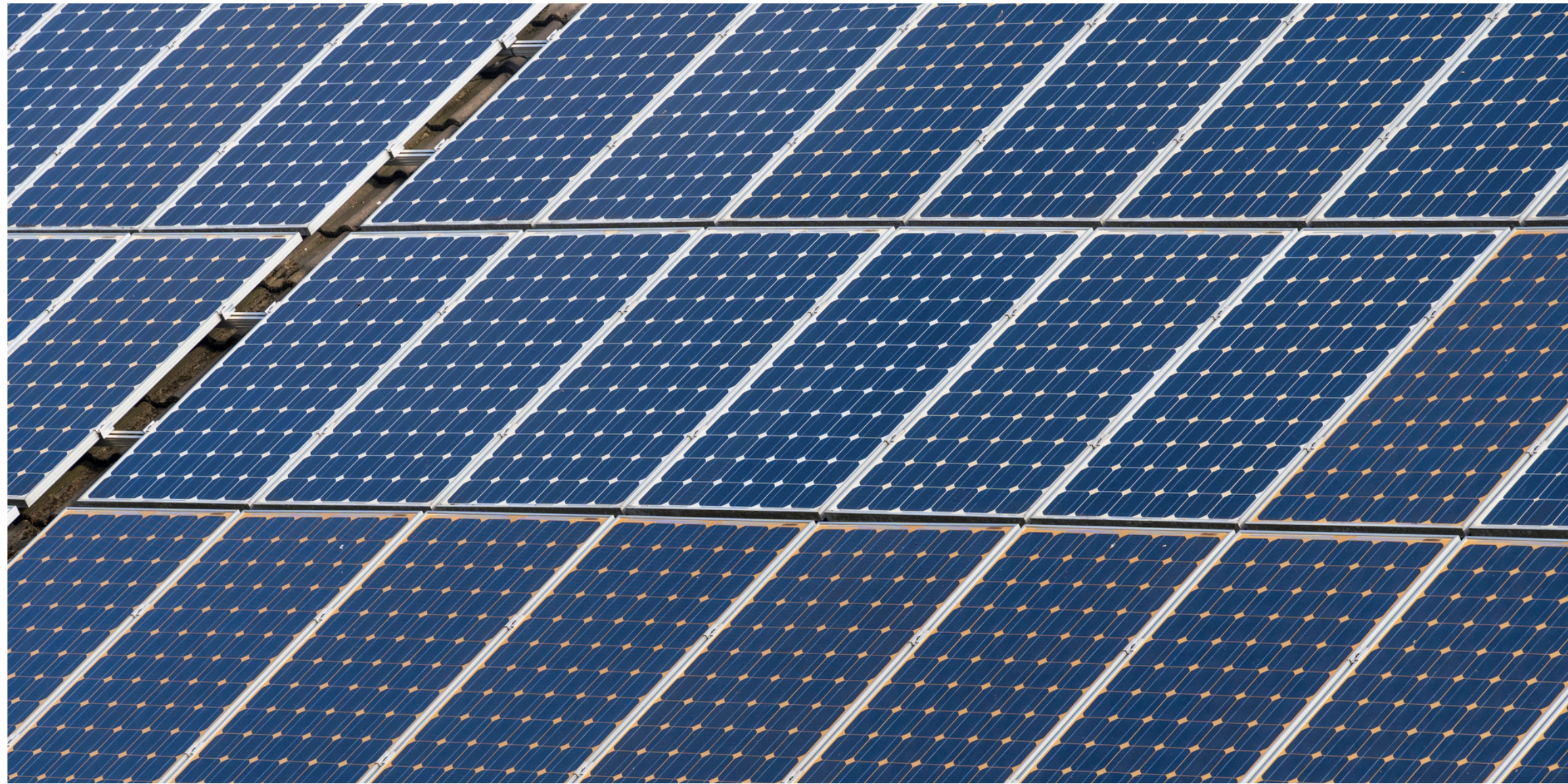

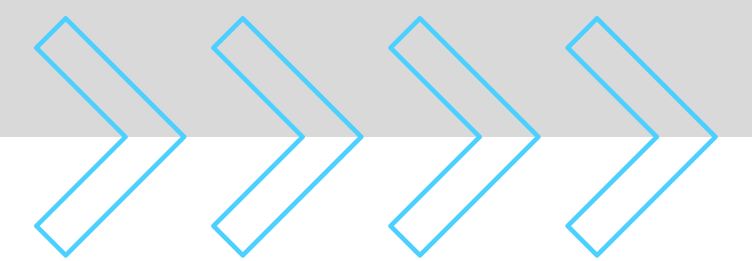

HIGHLIGHTS

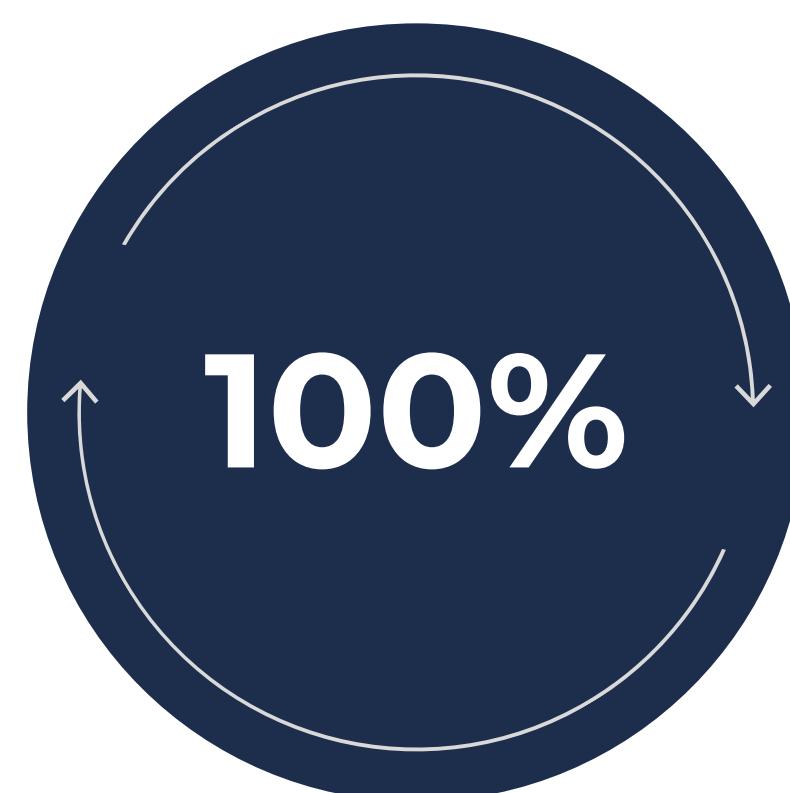
First State Bank of the Florida Keys funded this C-PACE transaction through FASTPACE.

- The \$424k C-PACE financing is the first **FASTPACE** closing in the state of Florida.
- C-PACE financing for the solar installation covered **100%** of project costs.
- The project will save an estimated **\$43K** in energy costs.



THE PROJECT

Jamaica Building is an industrial property located in Edgewood, a submarket of Orlando, FL. The C-PACE financing supported a solar installation that will provide energy savings for both of the building's tenants.
